### TERMS AND CONDITIONS FOR PHOTOGRAPHIC MATERIAL REQUESTS

1. The requesting entity shall state its specific needs, desires, reasons for the request, and provide detailed information explaining the specific use(s) and significant public purpose, which will be served through the granting of the reproduction. Permission to reproduce and all photographic material requests are for one time use as specified; photographs of artwork may not be reused without additional written permission.
2. The SFCA can grant permission requested only to the extent of its ownership of the rights relating to the request. Certain works of art owned by the SFCA may be protected by copyright, publication rights, or related interests not owned by the agency. The responsibility for ascertaining whether any such rights exist and for obtaining all other necessary permissions remains with the requester. The SFCA assumes no responsibility for royalties or fees claimed by the artist or other third parties.
3. In the reproduction process, artwork may not be cropped, bled off the page, printed on colored stock, overprinted or altered in any way without prior written consent of the APP Program. If a detail of artwork is used, it must be identified as such.
4. Duplicates may not be made of photographic materials supplied by the APP Program. If photographic materials are required in a different format, they may be created from the loaned materials, at the requester's expense. Upon project completion, all materials loaned and created must be returned to the APP Program.
5. The reproduction must be accompanied by ownership credit; this credit line shall be included in the caption or in immediate proximity to the reproduction. Unless otherwise specified, captions shall credit: **Hawaii State Foundation on Culture and the Arts.**
6. The following documentation must be included in the caption for each reproduced artwork: **title, artist, media, date of completion, dimensions, installation site (if permanent), and the photographer credit.** This information must appear either directly under the reproduction, on the page facing, or on the reverse.
7. The requester shall be responsible for any damage to or loss of photographic material(s) and the cost of repair or replacement. The APP Program reserves the right to determine the extent of damage and to assess the requester accordingly.
8. The requester shall be responsible for all shipping, mailing, freight and insurance costs for photographic material(s) to and from the SFCA office.
9. The APP Program reserves the right to refuse permission for further reproductions or loans from any requester, if, in its opinion, adherence to the terms of previous agreements was not upheld.
10. The APP Program reserves the right to deny permission for reproduction, if the use is deemed illustrative (and not directly related to the artist or artwork), inappropriate, or potentially damaging.
11. The APP Program is to receive three gratis copies of each publication in which the artwork appears, within 30 days of publication date.
